

Leading up to and on November 3rd, citizens of the United States will cast their vote for President and Vice President of the United States.

The 2020 election is the 59th presidential election in U.S. history.

HOW DOES ONE WIN THE ELECTION?

THE WINNING CANDIDATE MUST WIN 270 OUT OF THE 538 ELECTORAL VOTES.

ELECTORAL COLLEGE



The electoral college is a group of officials whose job it is to choose the president and vice-president of the United States.

They meet every four years, a few weeks after election day, to carry out that task.

HOW DOES THE ELECTORAL COLLEGE WORK?

- Each state gets the same amount of electors as it has lawmakers in Congress.
- If a candidate wins the popular vote in a state, the candidate wins <u>all</u> the electors of that state.

Example:

New Jersey has 14 electors.

If Trump wins, he gets all 14 electors' votes. If Biden wins, he gets all 14 electors' votes.


HOW DOES THE ELECTORAL COLLEGE WORK?

There are only two states that don't follow the electoral college's "winner takes all" rule:

Maine and Nebraska

In these states, the winner of the popular vote in each of its congressional districts is awarded one elector. Whoever wins the popular vote of the state then gets the two remaining electoral votes.





WINNING THE ELECTORAL COLLEGE

Each elector represents **one** electoral vote, and a candidate needs to gain a **majority** of the votes — 270 or more — to win the presidency.

To win the election, a candidate needs to win the popular vote in enough states to gain him 270 electoral votes.

MAIL-IN BALLOTS

Otherwise known as absentee ballots, a mail-in ballot is a vote cast by someone who is unable or unwilling to attend the official polling station to which the voter is normally allocated. Methods include voting at a different location, postal voting, proxy voting and online voting.

Because of Covid, mail-in ballots are being used in record numbers to avoid going to a physical polling site.




MAIL-IN BALLOTS

There are three different systems for deciding where to send mail-in ballots:

- Send to everyone
- Send to everyone who requested
- Only send to those who have a reason

Every state has its own policy on how they deal with sending out mail-in ballots.

DEMS VS. REPS ON MAIL-IN BALLOTS

There are more Democrat voters in the USA.

They believe that the reason they didn't win in 2016 is because not enough of their people cared to go out and vote.

Therefore, the more a state leans Democrat, the more easygoing the state will be on mail-in ballots.

They want to make it as easy as possible for their state voter base to vote.

DEMS VS. REPS ON MAIL-IN BALLOTS

Republicans understand that there are fewer Republican voters than Democrats.

If those Democrats don't all mobilize to vote, the Republicans have a chance of winning.

Therefore, the more a state leans Republican, the stricter the state will be on mail-in ballots.

DEMS VS. REPS ON MAIL-IN BALLOTS

That's politics.

When Republicans control the state, they'll make stricter voting laws to keep themselves in power.


When Democrats control the state, they'll make the laws more lenient to help them maintain power.

COUNTING ABSENTEE BALLOTS

Every state has its own policy on when the cutoff date for mail-in ballots should be.

For example:

- New Jersey's policy is that the ballot must be postmarked by Election Day and received 7 days after the election by 8 PM.
- Florida's deadline is that ballots must be delivered by 7 PM on Election Day.

PROBLEMS WITH MAIL-IN BALLOTS

There are some complications with mail-in ballots.

- How do we make sure that the person on the card is the one who actually sent in the ballot?
- What happens if signatures don't match?
- We know that mailings were dumped. We know that mailings went out to thousands of dead people.
- It's very possible that if votes were thrown out for having faulty signatures, the case may go to the courts for a recount.


ELECTION RESULTS

There's a chance we **won't** know who won the presidential election on election night. More people than ever are voting by mail this year due to the pandemic, and mail ballots take longer to count than ballots cast at polling places.

Each state has its own rules for how votes are counted and reported, some will report results sooner than others.

POLLS

Election polling and predictions are a significant part of any election year.

Parties need to know where to ramp up their efforts; businesses want to know what they should plan for over the coming year.

There are many political pundits, polling companies, and statisticians who focus on creating predictions of the upcoming election.

DIDN'T THEY GET IT WRONG LAST ELECTION?

Actually, no.


Polls predicted Clinton would win by an average of 3.2 percent. She WON the popular vote by 2.1 percent.

The polls were off by a small percentage, but it's a percentage that mattered a lot.

It's incredibly difficult to nail down the numbers in swing states because of the way people think about politics today. The pollsters missed that Trump would win by an average of 1.3 percent in the swing states.

POLLS SHOW A VERY CLOSE RACE

There is something called the "shy vote" or the "silent voter".

While polls have mainly predicted Biden as winner of the election, their data doesn't necessarily account for voters who haven't responded to them, answered the phone, or lied.

Trafalgar and the like seemingly account for those votes... which put Trump in the lead by about 2%.

That's a slim margin.

BLUE STATES VS. RED STATES

Blue = Democratic

When we hear that a state votes blue or red, we mean they predominantly support that party.

This creates a voting dynamic where just a few states are responsible for determining the winner of the election.

These states are called "swing states."

SWING STATES

A swing state is a state that does not consistently vote Red or Blue. They can "swing" either way depending on who the candidate for each party is.

The swing states are the deciders of the election.

Win the swing states and you win the election.

There are a total of 199 electoral swing votes.



WHAT HAPPENS IF THERE'S A TIE?

If neither candidate gets a majority of the 538 electoral votes, the presidential election is decided in the House of Representatives, with each state delegation having one vote.

A majority of states (26) is needed to win.

(Keep in mind that even though the House is controlled by Democrats, they won't get to pick the president, as Republicans control a greater number of states.)

Senators would elect the Vice-President, with each Senator having a vote.


A majority of Senators (51) is needed to win.

WHO IS WINNING IN THE SWING STATES?

As it stands, all major polling has Biden winning by a few percentage points.

The only poll showing Trump in the lead is the Trafalgar Group.

Most news agencies won't show them because they are considered controversial. This is because they claim to count the "shy vote" – something that is a very difficult task.



WHAT SHOULD WE BE FOCUSED ON NOW?

Trump has a decent chance to win Florida and Ohio. He is currently tied or has a slight lead in the polls, and we should know those results by 1:00 AM Eastern time.

If Trump wins those states...

And Pennsylvania...

He has a good chance of winning the election.

If he loses PA, or any of the three, he is likely to lose.



PENNSYLVANIA IS THE MOST IMPORTANT STATE TO WATCH


Pennsylvania's deadline for absentee ballots: They need to be postmarked on Nov. 3 or earlier and need to be received by Nov. 12.

Democrats are sending in mail-in ballots at a much higher rate than Republicans.


If Biden is tied or in the lead in Pennsylvania by 8:00 PM on Election Day, Biden will most likely win Pennsylvania and take the election.


If it's close or even if Trump has a small lead, we won't know until a few days after the election.


Swing State Polling Graph



That obviously includes the winner of this year's election.




